### **Definitions**

**Affiliates** - Companies related by common ownership or control. They can be financial and nonfinancial companies. *Autumn Lane Advisors, LLC has no affiliates.* 

**Nonaffiliates** - Companies not related by common ownership or control. They can be financial and nonfinancial companies. *These include broker/dealers, mutual fund companies, insurance companies and other financial institutions.* 

**Joint marketing** - A formal agreement between nonaffiliated financial companies that together market financial products or services to you. *Autumn Lane Advisors, LLC does not participate in joint marketing.*
